At the Annual General Meeting, shareholders

- ratified the re-appointment of KPMG Huazhen LLP as independent auditors of the Company for the financial year ending March 31, 2020, and authorized any duly formed committee of the directors to fix the remuneration of the independent auditors; and
- re-elected Mr. Albert Chen and Mr. Mark D. Chen as Class A directors of the Company until the 2022 annual general meeting of the Company or until their respective successors are duly appointed and qualified.

Global Cord Blood Corporation is the first and largest umbilical cord blood banking operator in China in terms of geographical coverage and the only cord blood banking operator with multiple licenses.
